The Focus on Youth Project Leads will be responsible for the program coordination and oversight, liaising and communication with 5 secondary schools, creating student referral packages, student registrations, creating of co-op credit opportunities, supervision of students, reporting, and budget considerations. They will work closely with the CODE Summer Program Vice-Principal and Summer School Principals to facilitate and support successful experiences for the Focus on Youth students attached to the program and programs offered at other Community agencies.

These positions involve a good deal of preparation in the Spring of 2024 prior to the commencement of summer school in addition to regular school duties. Report to the Board of Trustees about the program in Fall of 2024 is required.
