### HOMESTAY PARENT AGREEMENT

**In consideration of the Board's accepting the application of the Homestay Parent(s) to host an International student the Homestay Parent(s) understands and agrees with the Board as follows:**

1. all adults 18 years and older must provide the board a police records check (CPIC) at their own expense.
2. the fee paid by the student is \$750.00 per full month or pro-rated at a per diem rate of \$25.00.
3. confirms that all household members desire to host the international student.
4. to provide students with their own room with a suitable desk for study purposes and necessary items such as linens, towels, etc.
5. will provide a clean, orderly, pleasant and safe living environment for the student.
6. will provide the student three meals a day, seven days a week consisting of a variety of nutritional well-balanced foods. These meals should be taken with the family whenever possible.
7. will involve the student in family activities and outings.
8. will not require the student to maintain their house or yard, babysit children or cook their meals. With the exception of keeping their room and all other areas used, such as the kitchen and bathroom, clean and orderly.
9. will not leave students unsupervised overnight.
10. will not allow students under 18 years of age to take unsupervised out of town trips. The Supervisor of International should be informed of any and all trips taken by the International student.
11. shall discuss with the Supervisor of International any unresolved misunderstandings or conflicts between the Homestay Parent(s) and student(s).
12. will promptly notify the Supervisor of International of any changes with regard to household members (boarders, renters, family members moving in or out, etc.)
13. will notify the Supervisor of International if the student(s) attempts to move from their home.
14. shall not abuse alcohol or drugs.
15. shall not make improper advances toward the student(s).
16. must instruct the student on the course of action to take in the event of fire and other emergencies.
17. if the homestay parent(s) do not meet program standards at any time the student may, at the discretion of the Supervisor of International, be moved from their home, without notice or lieu payment.
18. take students at their own risk and the board is **not** responsible for any damages caused by the student(s).
19. the board does not assume any liability for problems created by the student (s) while being hosted, informs the Supervisor of International immediately of any alleged thefts that occur in the home or any alleged damage to the home committed or caused by the student(s).
20. the Supervisor of International will assist with mediation of any dispute between the student(s) and host parent with regards to alleged damage or theft. If necessary, the police may also be called.
21. the board will not be liable or responsible with regards to any theft or damage or for the provision of assistance in the collection of money for such theft or damage during or after the student(s) homestay placement.
22. they hereby waive, release and absolve and indemnify and save harmless the board and all those respective officers, directors, trustees, employees, representatives, agents and independent service provider(s) including but not limited to the transportation service selected for the student(s) from any and all of the actions, losses, damages and expenses including, without limitation, the loss or theft of money, property damages or losses, personal injuries, or deaths however caused.
