#### 8. Fundraising Update – 25 Year Anniversary

The goal is to raise \$2,500 that will go directly to the Foundation. The Board of Directors had a discussion around updating the ALCE Foundation Logo. Ms. Leila Nasr-Sharifi shared that she had sourced a quote from a design company the Board has worked with in the past and the funds to source the logo would come from the foundation budget.

Ms. Sheena Cassidy suggested the Committee consider putting it out to ALCDSB Schools and have a student designed logo at no cost, sharing it would be nice as it is the children's foundation.
